

RESOLUTION 2012-13

RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION FOR A LIBRARY COMPUTER GRANT FROM USDA RURAL DEVELOPMENT AND AUTHORIZING THE ACCEPTANCE OF SAID GRANT FOR THE FISCAL YEAR ENDING JUNE 30, 2012.

WHEREAS, Weakley County Ned R. McWherter Library intends to apply for a computer grant from USDA Rural Development; and

WHEREAS, the grant contract, in the amount of \$2,042.00 will be used to purchase computer equipment, computer furniture, and provide for the computer electrical connections at the Weakley County Ned R. McWherter Library; and

WHEREAS, the USDA grant will impose no legal obligations upon Weakley County, the grant will be 100% funded by USDA Rural Development.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th day of September, 2011 in Dresden, Tennessee that:

SECTION 1. BE IT FURTHER RESOLVED, that Houston Patrick, County Mayor is authorized to apply, on behalf of Weakley County, for a computer grant from USDA Rural Development in the amount of \$2,042.00. Should said application be approved by USDA Rural Development then Houston Patrick, County Mayor is authorized to execute contracts or other necessary documents, which may be required to signify acceptance of the grant.

SECTION 2. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee which are in conflict with this resolution are hereby repealed.

SECTION 3. BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.




