

RESOLUTION NO. 2012-23

RESOLUTION AUTHORIZING BUDGET AMENDMENTS FOR WEAKLEY COUNTY, TENNESSEE SOLID WASTE FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2012

WHEREAS, the State of Tennessee Department of Environment and Conservation has awarded Weakley County a \$7000 waste oil grant; and

WHEREAS, the grant is 100% state funded with no local funds involved; the grant funds will be utilized for the purchase and installation of a used oil heater for the Weakley County Service Station building.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17th day of January, 2012 in Dresden, Tennessee that this resolution is hereby approved.






