

RESOLUTION NO. 2012-24

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2012.

WHEREAS, the State of Tennessee has awarded the Weakley County Sheriff's Department a \$5,000 Highway Safety grant, with no local match, to purchase vehicle in-car video equipment, mobile radar unit, laptop computer, and other law enforcement equipment; and

WHEREAS, Weakley County maintains sexual offender registration reserved funds, these funds can be utilized to maintain such electronic records; and

WHEREAS, the Sheriff's Department wishes to replace such computer equipment to continue proper sexual offender registration record maintenance.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17th day of January, 2012 in Dresden, Tennessee that:






