

RESOLUTION NO. 2012-32

**RESOLUTION ACCEPTING THE RESIGNATIONS OF DISTRICT 1
COMMISSIONER ANDY HOLT AND DISTRICT 3 CONSTABLE MITCHELL GREUB**

WHEREAS, District 1 County Commissioner Andy Holt has resigned his position effective February 15, 2012; and

WHEREAS, District 3 Constable Mitchell Greub has resigned his position effective February 20, 2012; and

WHEREAS, the Weakley County Legislative Body is authorized to fill these vacancies until a successor is elected at the next general election in the county and is qualified.

NOW THEREFORE, BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th of March 2012 in Dresden, Tennessee that:

SECTION 1. The resignation of District 1 Commissioner Andy Holt is accepted and that his successor be appointed by the county legislative body from County Commission District 1 as described in Resolution 2012-07 adopted by the county legislative body on September 19, 2012.

SECTION 2. The person appointed shall serve on the Public Works Committee and the Personnel, Legislative, & Intergovernmental Committee of the County Legislative Body.


