

RESOLUTION NO. 2013-08

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2013.

WHEREAS, upon review by the State of TN Office of Local Finance, the Weakley County General Fund budget 12-13FY should be reduced in order to reflect a positive cash flow for each of the twelve months of the current fiscal year; and

WHEREAS, the Weakley County Legislative body appropriated the \$101,000 to repair and replace the Courthouse HVAC equipment while this is needed, it appears to be currently running properly and this project can be deferred until next fiscal year.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17th day of September, 2012 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:


