

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENNESSEE, GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2015.**

**WHEREAS**, the FCC Narrowband Mandate of public safety radio spectrum has caused a significant decrease in the coverage area for Weakley County law enforcement, fire, and Emergency Medical Services, thereby placing the safety of emergency responders and the public at great risk, and

**WHEREAS**, the Weakley County 9-1-1 Board studied the impacts on the responders and citizens of Weakley County, and thereby committed to the prospect of erecting a new public safety tower site to mitigate injury and loss of life within Weakley County, and

**WHEREAS**, the Weakley County 9-1-1 Board voted on September 11, 2014 to provide reimbursement to the Weakley County Emergency Management Agency for the construction and completion of a new public safety tower site, in an amount not to exceed \$450,000, at the Weakley County Correctional Complex, 7951 Hwy 22, Dresden, Tennessee, and

**WHEREAS**, Weakley County Office of Emergency Management is to receive an amount up to \$450,000 through the inter-local agreement with Weakley County 9-1-1 Emergency Communications District for the purchase and building of a new public safety tower facility, and has need to incorporate such revenue and expenditures in the budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of Weakley County, Tennessee, assembled in regular session on this the 17th day of November, 2014 that:

**Section 1:** The General Fund is hereby amended as follows:


