**Resolution Authorizing Budget Amendments
To The General Purpose School Fund
For The Fiscal Year Ending June 30, 2017**

WHEREAS, adjustments need to be made in the General Purpose School Budget; and

WHEREAS, amendments need to be made in the General Purpose Special Education Program to include additional revenue from the State for reimbursemen of high cost expenditures for IDEA students that occurred in the 2015-16 school year.

SECTION 1: The General Purpose School Fund is hereby amended as follows:


