

RESOLUTION NO. 2017-38

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2017.

WHEREAS, the Weakley County Detention Center has had considerable repairs and replacement to plumbing and HVAC equipment; and

WHEREAS, the Weakley County Detention Center has seen an increase in food supplies due to a rise in inmate population; and

WHEREAS, the Weakley County Detention Center is in need of realignment in expenditure line items.
