

**RESOLUTION TO FIX THE JAILER'S FEE FOR WEAKLEY COUNTY, TN**

**WHEREAS**, *Tennessee Code Annotated*, Section 8-26-105 authorizes county legislative bodies to pass a resolution fixing the amount of jailer's fees which may be applied to misdemeanor prisoners for each twenty-four hour period the prisoner is confined to the Weakley County Detention Center; and,

**WHEREAS**, the Weakley County legislative body of Weakley County fixed the jailer's fees at thirty-five dollars (\$35.00) per misdemeanor prisoner per calendar day of confinement by Resolution No. 1999-67, and authorized the cap on the jailer's fee in Resolution No. 2010-17; and,

**WHEREAS**, the county legislative body of Weakley County desires to be fully compensated for the housing of misdemeanor prisoners; and,

**NOW, THEREFORE BE IT RESOLVED**, that the county legislative body of Weakley County, Tennessee, assembled in regular session on this the 29<sup>th</sup> day of June, 2017 in Dresden, Tennessee, that:

**SECTION 1.** The jailer's fee for Weakley County is hereby fixed to be equivalent to the State reimbursement rate but with a minimum fixed rate of no less than thirty-nine dollars (\$39.00) per day per misdemeanor per twenty-four (24) hour period of confinement in the Weakley County Detention Center.

**SECTION 2.** The jailer's fee herein fixed shall be collected by the clerk of the appropriate court as a part of the fines and costs imposed in each misdemeanor case upon finding guilt.

**SECTION 3.** A copy of this Resolution shall be transmitted to each clerk of court hearing criminal matters in Weakley County and shall be spread upon the minutes of this meeting by the County Clerk.

**NOW, THEREFORE BE IT FURTHER RESOLVED**, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee which are in conflict with this resolution are hereby repealed.

**NOW, THEREFORE BE IT FURTHER RESOLVED**, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.




