

**Resolution No. 2018-09**

**Resolution Authorizing Budget Amendments To The Weakley County, TN Highway Fund For The Fiscal Year Ending June 30, 2018**

**WHEREAS**, the Tennessee Department of Transportation has issued a one-time allotment to counties to be used on State Aid roads only; and,

**WHEREAS**, funds in the amount of \$557,800 will be received in the revenue line of State Aid, with the total placed in the expenditure line totaling \$569,200, and 2% of which is a county match equivalent to \$11,400; and,

**NOW, THEREFORE, BE IT RESOLVED** by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 18th day of September, 2017 in Dresden, Tennessee that this resolution is hereby approved.

**SECTION 1:** The Weakley County Highway Fund is hereby amended as follows:
