

**Resolution No. 2020-09**

**Resolution Authorizing Budget Amendments To The Weakley County, TN  
General Fund For The Fiscal Year Ending June 30, 2020**

**WHEREAS**, the Weakley County General Fund Budget for the FY 2019-20 is in need of realignment in estimated expenditures due to the fact that the Weakley County EMA Director was hired on August 1, 2019, and is participating in the county's health insurance plan. The previous EMA Director did not participate in the county's health insurance plan, and, therefore, no expenditures were budgeted for the county's portion of the employee's health insurance coverage.

**NOW, THEREFORE, BE IT RESOLVED** by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 16th day of September, 2019, that:

**SECTION 1:** The Weakley County General Fund is hereby amended as follows:




