

Resolution Authorizing Budget Amendments To The Weakley County, TN
General Fund For The Fiscal Year Ending June 30, 2020

WHEREAS, the Weakley County General Fund Budget for the FY 2019-20 is in need of realignment to include additional revenue from the Department of Mental and Substance Abuse Services in the amount of \$40,000, as well as including expenditures corresponding to the additional awarded revenue.

NOW, THEREFORE, BE IT RESOLVED by the county legislative body of Weakley County, Tennessee, assembled in regular session on this the 18th day of November, 2019, that:

SECTION 1: The Weakley County General Fund is hereby amended as follows:


