Resolution Authorizing Budget Amendments To The Weakley County, TN General Purpose School Fund For The Fiscal Year Ending June 30, 2020

WHEREAS, the Weakley County General Purpose School Fund Budget for the FY 2019-20 is in need of realignment to reflect additional revenue, and related expenditures, awarded through the TVA STEM Classroom Grant Program.
