

**RESOLUTION NO. 2020-59
CORRECTING A SCRIVENER'S ERROR IN THE NUMBERING OF RESOLUTIONS
IN THE RECORDS OF THE WEAKLEY COUNTY LEGISLATIVE BODY
FOR THE FISCAL YEAR ENDING JUNE 30, 2020**

WHEREAS, a scrivener's error was recently discovered for certain Resolutions passed through the Weakley County Legislative Body on May 26, 2020;

WHEREAS, certain scrivener's errors were found in which duplicate resolution numbers were assigned to resolutions, creating possible confusion in the records of the legislative body; and

WHEREAS, it is the intent of the Board by the passage of the Instant Resolution to correct and remedy said scrivener's error to renumber and reassign resolutions that were passed on May 26, 2020, to alternate numbers that have not yet been assigned in the 2019-20 fiscal year.

NOW, THEREFORE, BE IT RESOLVED by the county legislative body of Weakley County meeting in regular session on this 30th day of June, 2020, in Dresden, Tennessee, that:

SECTION 1. Resolution No. 2020-43, passed on May 26, 2020, Authorizing Budget Amendments to the Weakley County, Tennessee, General Purpose School Fund for the Fiscal Year Ending June 30, 2020, shall be assigned Resolution No. 2020-56; and

SECTION 2. Resolution No. 2020-44, passed on May 26, 2020, Authorizing The Submittal of An Application To the Economic Development Administration [EDA] Coronavirus Aid, Relief, and Economic Security (CARES) Act For Public Works And Economic Adjustment Assistance Funding Opportunity, shall be assigned Resolution No. 2020-57; and

SECTION 3. Resolution No. 2020-45, passed on May 26, 2020, Authorizing Budget Amendments to the Weakley County, Tennessee, General Fund for the Fiscal Year Ending June 30, 2020, shall be assigned Resolution No. 2020-58; and

BE IT FURTHER RESOLVED that this resolution shall be spread upon the minutes of the Board of County Commissioners and that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed, and that this resolution shall take effect upon adoption, the general welfare requiring it.


