Resolution Authorizing Budget Amendments To The General Purpose School Fund For The Fiscal Year Ending June 30, 2022

WHEREAS, additional monies have been awarded through the State of Tennessee for reimbursement of IDEA Part B Preschool high cost expenditures; and

WHEREAS, Weakley County has been awarded a grant to purchase hydroponics systems for the Weakley County Schools' greenhouses; and
